### Your W-2 contains key tax information, including:

- Box 1: Total federal taxable wages (includes wages, non-cash fringe benefits, imputed income, and taxable reimbursements).
- Box 2: Total federal income tax withheld.
- Boxes 3 & 5: Wages subject to Social Security and Medicare taxes.
- Boxes 4 & 6: Social Security and Medicare taxes withheld
- Box 10: Dependent Care FSA deductions.
- Box 12: Various deductions, including 403(b) 457, HSA Contributions and employer-sponsored health coverage (DD). Refer to the W-2 instructions for details.
- Box 13: Checked if you are a member of the University of California Retirement Plan.
- Box 14: May contain information about DCP CAS (Safe Harbor defined contribution), DCCHOICE or UCRP.
- Boxes 15 – 20: State and local tax details where applicable.
